Sulphur is generated and removed from alkylate-type gasoline by a process known as xe2x80x9cslurry dewaxingxe2x80x9d. See, for example, U.S. Pat. Nos. 5,395,906 and 5,578,421. The separated naphthene fraction is subsequently recycled for the dewaxing process. In the U.S., it is common for xylene feeds from alkylation units to include 1.5 to 5.0% by weight of toluene. Various methods have been proposed to achieve separation of naphthene from this mixture. For example, U.S. Pat. No. 5,396,001 proposes separating toluene from the naphthene fraction using distillation. U.S. Pat. No. 5,578,421 also proposes a continuous-type flow dewaxing process in which a portion of the toluene-containing naphthene is mixed with the hexane and naphthene feed and sent to the dewaxing unit. Dewaxing a toluene-containing naphthene to remove small amounts of naphthene in a naphthene-containing fraction is a difficult task. The boiling points of toluene and naphthene are approximately 8xc2x0 C. and 45xc2x0 C. respectively. The boiling points are close enough that each component can interfere with the separation of the other component. A
